- 1. The remote e-voting period remained open from Friday, 29th December 2023 from 09:00 a.m. (IST) up to Saturday, 27th January 2024 at 5:00 p.m. (IST). The Company had sent the Postal Ballot Notice to all the Members of the Company electronically only, on 28th December 2023 whose names appear on the Register of Members / List of beneficial owners as on Tuesday, 26th December 2023 ("Cut-Off Date") received from the Depositories and whose email IDs were registered with the RTA/ Depository Participants.
- 2. The Company has engaged the services of Link Intime India Private Limited (LIIPL) as the Authorized Agency to provide secured system for remote e-voting process.
- 3. The Cut-off date for the purpose of determining the entitlement for electronically voting, by postal ballot on the proposed resolution was Tuesday, 26th December 2023.
- 4. In accordance with Sub-rule 4(v) of Rule 20 of Companies (Management and Administration) Rules, 2014 as amended from time to time & MCA General Circulars Nos. 14/2020 dated 3th April, 2020,17/2020 dated 13th April, 2020, 20/2020 dated 5th May, 2020 and 2/2021 dated 13th January, 2021 19/2021 dated 8th December 2021, and No. 21/2021 dated December 14, 2021, No. 02/2022 dated 5th May 2022, No.10/2022, No.11/2022 dated 28th December 2022 and, 09/2023 dated 25th September 2023 respectively issued by the Ministry of Corporate Affairs ('MCA Circulars') and SEBI Circulars Nos.
